#### 4.1 Description of first aid measures

## **General Advice**

Consult a doctor and show this safety data sheet.

## If Inhaled

Acetonitrile Solution - Remove victim to fresh air and keep at rest in a position comfortable for breathing. Call a POISON CENTER or physician if you feel unwell.

Trifluoroacetic Acid - Remove to fresh air and monitor breathing. If breathing becomes difficult, give oxygen. If breathing stops, give artificial respiration. Consult a doctor.

## In Case of Skin Contact

Acetonitrile Solution - Wash with plenty of soap and water. Remove contaminated clothing and shoes. Wash contaminated clothing thoroughly with water before removing it, or wear gloves.
